### **INTERNATIONAL MISSING PERSON'S DAY – 25<sup>th</sup> May 2019**

What we know in Cheshire is that most of our children and young people go missing on less than 3 occasions; however the risks are still there, so prevention is key. YoungAddaction have worked closely with parents of these young people to create an advice resource for other parents around missing from home. ### **DISRUPTION AROUND EXPLOITATION**

The Home Office have recently completed a national consultation and have now published a Child Exploitation Disruption Toolkit for professionals working with children in the UK. The toolkit sets out key legislation that can be used to disrupt the criminal and sexual exploitation of children and includes best practice guidance around information sharing and multi-agency working: [Child exploitation disruption toolkit \(PDF\)](#)
