Strategic Funds & Council Specific (Borough-wide significance)

SUSTAIN'S FOOD FOR THE PLANET CAMPAIGN GRANTS

Deadline:

The closing date for applications is the 10th February 2023.

Details:

Grants of up to £5,000 are available to local sustainable food partnerships, local authorities, community, or campaign groups to support communities in promoting & advocating for food that is better for both people & environment. Sustain is an alliance working together for a better system of food, farming, fishing, & cultivating movement for change. Applicants are encouraged to submit own ideas for local action, with focus on areas that have a significant impact locally i.e.:

- Improving your council's score in Every Mouthful Counts report/developing a food strategy.
- Supporting groups and communities that are marginalised to campaign for food climate justice & tackling racial injustice in the food system.
- Encouraging climate-friendly food in public institutions & council settings.
- Supporting sustainable farming systems through planning policy.
- Tackling unfair and unhelpful pricing & advertising of the most climate-damaging foods.

PARENTAL CONFLICT CHALLENGE FUND 2

Deadline:

The deadline for applications is the 24th February 2023.

Details:

Local authorities, other organisations (private sector companies in digital fields), social enterprises, voluntary or community organisations can apply. Programme was established to aid families in which children are exposed to conflict. Successful applicants will receive a minimum of £150,000 to support their projects, which must be run between June '23-November '24. Projects must fall into one or both of the following categories: those that aid diverse families at greater risk of parental conflict & those that utilise digital tools to assist parents experiencing conflict &/or self-guided tools that can be integrated into government services. The programme aims to reduce conflict & provide healthier environments for children to grow up in & reach their full potential as adults.

WAR MEMORIALS GRANT SCHEME

Deadline:

The next closing date for applications is the 28th February 2023.

Details:

The War Memorials Trust is providing grants for the repair/conservation of free-standing war memorials. Grants are intended to help those who are responsible for the upkeep of war memorials. Grants support the care & preservation of war memorials to a high standard & to prevent the decay of this important part of our built heritage. Grants will normally be for 25%-75% of eligible costs. Max grant is £5,000 for non-freestanding war memorials while freestanding, non-beneficiary war memorials may be considered up to a maximum grant of £20,000. Fund is open to anyone to apply; individuals or organisations, including councils.

GET FISHING FUND

Deadline:

The application deadline is the 5th March 2023.

Details:

To promote the healthy benefits of fishing, the Environment Agency and Angling Trust have launched a new £100,000 funding round from the Get Fishing Fund. The aim of the fund is to inspire more people to start fishing or go back to fishing. Funded by the sale of fishing licenses, grants of up to £2,500 are available to fishing clubs, fisheries, charities, schools and local authorities in the UK for projects based on fishing activity. Funding can be used to help purchase equipment, fishing gear, and resources to organize fishing events and activities that provide opportunities for everyone to get involved in fishing.

FCC COMMUNITY ACTION FUND

Deadline:

The fund will close on 5pm on 8th March 2023.

Details:

Registered charities, churches, parish councils, local authorities & CASC registered sports clubs can apply for grants of £2,000-£100,000 for the provision, maintenance or improvement of community facilities. This includes village halls/community centres, public play areas; publicly available multi use games areas/skate parks/BMX tracks; sport/recreation grounds including pavilions/clubhouses with full public access; churches – community spaces only; nature reserves/public gardens/parks/country parks/woodlands with at least dawn to dusk access. Funding available to projects located within 10 miles of an eligible FCC Environment site.

ONE PUBLIC ESTATE BROWNFIELD LAND RELEASE FUND

Deadline:

The closing date for applications is the 23:59 on the 31st March 2023.

Details:

The Dept. for Levelling Up, Housing & Communities announced that disused & underutilised brownfield sites will be revitalised to provide thousands of new homes & jobs. Local councils can apply for a portion of £60m from Fund, which aims to revitalise neglected urban areas, support regeneration projects, & boost local economies. This initiative is part of the government's plan to prioritise brownfield land for housing development, while preserving green spaces & turning underused sites into desirable places to live and work. Out of the £180m fund, £35m has already been allocated & the remaining funding will be made available to councils over the next 2 years.

THE REES JEFFRIES ROAD FUND

Deadline:

Applications for funding must be submitted by 31st March 2023.

Details:

Funding is available to organisations & individuals for research, education, & community projects that aim to improve and enhance road design, engineering, and aesthetics, with a focus on improving the experience of road users. Funding can include things like traffic engineering & transport planning courses, and research projects to improve the highway network and roadside environments, such as parks/open spaces. Trustees favour proposals that have national, rather than local, significance and those which involve other funding partners. They welcome proposals and ideas for innovative topics and projects. There are no specific minimum or maximum grant amounts listed, but most grants awarded in the past have been between £5,000 and £30,000.

BME YOUTH THROUGH THE TOGETHER FUND

Deadline:

Applications will be accepted at any time until 31st March 2023 or until all funds are allocated.

Details:

Grants of up to £10,000 are available to charities, community groups, local authorities, clubs, and other not-for-profits delivering sports and physical activities to improve the health and wellbeing of black, Asian and minority ethnic children and young people in England. The funding is made available to help people who are most in need of support to get & remain active particularly those from culturally diverse communities, disabled people, lower socioeconomic groups and people with long term health conditions. Funding can be used for equipment, coach fees and expenses, hire of facilities, promotion and publicity, staff costs, and transport.

HOLIDAY ACTIVITIES AND FOOD PROGRAMME

Deadline:

No deadline specified.

Details:

The UK government has announced £200m in funding during 2023 to support the Holiday Activities & Food Programme, which provides free meals & activities to children in disadvantaged areas during school holidays. Funding for the programme in 2023 will allow every local authority to continue supporting families in need. The programme is targeted at school-aged children from reception to year 11 who are eligible for benefits-related free school meals and is available during the summer, Easter & Christmas breaks. The government is also extending the Household Support Fund, which provides small payments for food, clothing, and utilities to vulnerable households, until March 2024 with an additional £1bn in funding.

AUTOMATED EXTERNAL DEFIBRILLATORS FUND

Deadline:

Deadline TBC.

Details:

The Dept. of Health & Social Care is launching a £1m fund to increase the number of Automated External Defibrillators (AEDs) in underrepresented communities. The Fund is available to those organisations seeking funding to purchase & install AEDs. These organisations will be required to match the funding they receive, potentially doubling the number of new AEDs created. The fund's independent partner will work with the Dept. of Health & Social Care to ensure that the AEDs are placed in areas with high foot traffic, vulnerable populations, rural areas, or locations where specific activities take place & ensure that new defibrillators in the community are accessible on a 24/7 basis & are equally accessible to all social groups.

SMART ENERGY GB IN COMMUNITIES FUND

Deadline:

Applications must be received by 12 noon on the 10th February 2023.

Details:

Grants of up to £25,000 are available to charities & other not-for-profits for projects which help vulnerable people to understand & benefit from smart meters in their homes. Grants will be awarded to regionally based organisations, with local networks that are able to reach people facing barriers to using smart meters. 3 funding streams are available, each targeting a specific audience:

- Grants for organisations reaching *people who are in fuel poverty*. The total amount of funding requested should be between £15,000 and £25,000.
- Grants for organisations reaching *people who are lacking basic digital skills*. The total amount of funding requested should be between £10,000 and £15,000.
- Grants for organisations reaching people who are carers. The total amount of funding requested should be £5,000. Grants for organisations reaching *people who are carers*. The total amount of funding requested should be £7,500 and £10,000. associations and local authorities are also eligible to apply.

MCCARTHY STONE FOUNDATION SMALL GRANTS PROGRAMME

Deadline:

Applicants should submit an expression of interest in the first instance by the 15th February 2023.

Details:

Grants of up to £7,500 are available for organisations working on intergenerational activities and/or community regeneration that benefit the health & wellbeing of older people. The aim of this funding is to support older people facing isolation, loneliness, or poor health; young people who may be falling behind personally & academically; & communities in need of regeneration. To be eligible for funding, applicants must have an annual income below £500,000 & no more than 12 months of operating costs in reserves. Types of projects that have been previously supported include an intergenerational dementia allotment project & regeneration of community spaces.

Details:

Environmental charities across the UK are invited to apply for match funding to support projects which address the climate emergency. Launched by the Big Give, the Green Match Fund is a match funding campaign that runs for one week in April. All public donations made to participating charities during the campaign will be matched up to a specific amount - either £2,500, £5,000 or £10,000. Match funding is provided by the Big Give's Champions which has previously included the Reed Foundation, Garfield Weston Foundation and several other philanthropists and funders.

Details:

Naturesave Trust announced next application window will open on 1st January 2023. The theme for this funding round will be tackling pollution & single-use plastic. Trust is looking for community projects who are running initiatives to tackle these issues. Each year the Trust donates a percentage of their income generated & uses these funds to support environmental and conservation projects. COASTAL FOUNTAIN FUND 2023

Details:

Sea-Changers Coastal Fountain Fund 2023 aim is to help reduce the impact of single-use plastic water bottles on coastal habitats. The fund helps community organisations to purchase water fountain bottle filling stations for installation in busy or particularly environmentally important coastal areas. Grants of up to £2,500 are available to cover the cost of purchasing one water fountain unit and does not cover installation or maintenance costs. Funding is for the costs of purchasing a water foundation only, rather than for installation or maintenance costs.

Details:

The Reclaim Black Heritage Fund, offering several Black-led groups and Black individuals the opportunity to apply for funding to celebrate 81 acts of rebellion against inequity. The fund's priority is to support projects that commemorate these uprisings and benefit the Black community in the specified location. According to the Ubele Initiative, the Reclaim Black Heritage Fund aims to "commemorate the 81 uprisings that have shaped our history, and to benefit and support the Black community in the stated location." The fund is open to Black-led groups and individuals who are developing projects that align with the 81 Acts Humanifesto. MATTHEW GOOD FOUNDATION'S GRANTS FOR GOOD FUND

The next deadline for applications is the 15th March 2023.

Details:

The aim is to support small charities, not-for-profits & social entrepreneurs who are passionate about making a difference to people, their community or the environment. The Fund will share £10,000 between 5 shortlisted projects, which will be voted for by John Good Group employees. The project that receives the most votes will receive a grant of £3,500, second place £2,500, third place £2,000 with fourth and fifth place both receiving £1,000. As well as established projects and charities, the Foundation want to hear from people with innovative ideas that need some funding to get their projects up and running. BRITISH ECOLOGICAL SOCIETY OUTREACH GRANTS

Deadline:

The closing date for applications is 5pm on the 15th March 2023.

Details:

Individuals, & organisations such as schools, museums, libraries, & community groups will be able to apply for grants to promote ecological science to a wide audience. Funding is available for projects that increase public understanding of, & engagement with ecology by:

- Increase public understanding of, and engagement with, ecology.
- Stimulate discussion about ecology and its implications for society.
- Inspire and enthuse people of all ages about the science of ecology, especially those not previously interested.
- Develop skills in communicating the science of ecology.

Applications from museums and schools are welcome but projects must involve significant outreach beyond schools as those aimed solely at delivering curriculum to school children will not be considered. Grants are not awarded for purely nature conservation purposes or any activity that does not promote the science of ecology. Projects supported will:

- Be aimed at a non-academic audience.
- Provide a clear demonstration of direct interaction with the audience.
- Show evidence of links to the research community at UK, regional and international levels, where appropriate.

The maximum award is £2,000 which may form all or part of the total costs of the project. Larger projects involving other sponsors are also funded.

HELP THE HOMELESS

Deadline:

The closing date for applications is the 15th March 2023.

Details:

Homeless charities can apply for capital grants of up to £5,000 for projects that aim to help homeless people return to the community and enable them to rebuild their lives. Typically, such organisations may operate small or medium-sized residential or training facilities to assist homeless people. To be eligible to apply, the charity must have an annual turnover of under £1 m & with 'unrestricted reserves' of under six months.

CASH FOR KIDS COST-OF-LIVING CRISIS

Deadline:

Cash for Kids aims to get the funds to families as soon as possible.

Details:

A new £1m fund has been launched to support the UK's most vulnerable families during the cost-of-living crisis. The Cash for Kids Cost of Living Fund will target families who have a genuine need for support and are suffering from disadvantage due to the crisis, allowing them to apply for grants of £50 per child which can be used for essentials such as food, heating, clothing, and school uniform. Service providers who support vulnerable children, including schools, social services, health professionals and charities, can apply on behalf of the families they work with. Applications will close when all funding has been allocated.

CLIMATE ACTION FUND

Deadline:

There is no deadline and applications are being accepted on an ongoing basis.

Details:

Up to £8m is available to community projects that are focusing on the link between nature & climate. Groups can apply for funding of up to £1.5m over 2-5 years to support place based & UK-wide partnerships that use nature to encourage more community-led climate action and help communities tackle climate change. The National Lottery Community Fund expects most projects to be funded between £300,000-£500,000. Development grants of £50,000-£150,000 over 12-18 months are also available for those communities wanting to develop initial ideas. National Lottery Community Fund is interested in projects that can do at least one of the following:

- show how creating a deeper connection with nature will lead to changing people's behaviours and greater care for the environment.
- show how by bringing nature back into the places we live and work, we can help communities to reduce or adapt to the impacts of climate change.

It is anticipated that 12-15 projects will be funded. Applications will be accepted from: local partnerships or UK-wide partnerships which are delivered across at least 2 UK countries.

Details:

Charities/social enterprises which are struggling with rising energy costs can apply for unsecured loans of £20,000-£150,000 to install energy efficiency & renewable energy measures. The programme will enable organisations to save money by installing variety of measures i.e.: Insulation; Buying and installing renewable energy equipment; Heat exchangers & heat pumps; LED light installations; Replacing old gas fired boiler systems with new efficient ones; Property improvements, such as extra single glazing on existing windows, double glazing improvements, systematic draught improvements or Energy efficiency survey and technical assistance costs.

Details:

The Clothworkers Foundation awards grants to charities & other not for profits (inc. special schools) to support capital projects that support disadvantaged sections of the community. This can include the purchase or renovation of buildings & the purchase of equipment & vehicles. To be eligible the projects must fit within one or more of the Foundation's specified programme areas. This includes alcohol/substance misuse; disadvantaged minority communities; disadvantaged young people; domestic & sexual abuse; homelessness; domestic & sexual abuse; and older people. The Foundation aim to make a decision within 8 weeks for grants & projects less than £10,000 or within 6 months for grants over £10,000.
