Strategic Funds & Council Specific (Borough-wide significance)

THEATRES TRUST SMALL GRANTS PROGRAMME

Deadline:

The deadline for applications in this round is 12pm on the 21st April 2023.

Details:

Theatres Trust small grants programme is for not-for-profit theatres to carry out essential works. Priority will be given to improvements to buildings that protect theatre use & remove barriers to participation & attendance. The Small Grants Programme will provide grants of up to £5,000 to support essential small projects that make a big impact to a theatre's resilience, sustainability, or accessibility. To be eligible, applicants must demonstrate that they: own or manage theatres with titles or signed leases of more than 5 years on buildings; run a year-round programme of live performance, of no less than 30 performances a year or have a bona fide UK charitable or not-for-profit legal structure and be able to provide certified or audited accounts for at least 2 years. Eligible projects include small capital works, installation of key plant/machinery, works that make theatre buildings digital-ready, & projects that help theatres reopen as Covid-secure.

FCC COMMUNITY ACTION FUND

Deadline:

The fund will re-open for applications on 22nd March until 5pm on the 7th June 2023. **Details:**

Registered Charities, churches, Parish Councils, Local Authorities & CASC registered sports clubs can apply for grants of £2,000-£100,000 for provision, maintenance, or improvement of community facilities. This includes Village Halls, Community Centres; Public Play Areas, publicly available Multi use games areas, Skate parks, BMX tracks; Sport & recreation grounds including pavilions, clubhouses with full public access; Churches (community spaces only), museums, Nature Reserves, Public gardens, parks, country parks/woodlands (least dawn to dusk access). Funding is available to projects located within 10 miles of an eligible FCC Environment site. Recent policy changes mean that wel now accept applications for renewable energy projects at community buildings. Applications for non-substantial extensions (toilets/kitchens are sometimes accepted). **How to apply:**

WAR MEMORIALS GRANT SCHEME

Deadline:

The next closing date for applications is the 30th June 2023.

Details:

The War Memorials Trust is providing grants for the repair and conservation of free-standing war memorials. Grants are intended to help those who are responsible for the upkeep of war memorials. Grants support the care and preservation of war memorials to a high standard, and to prevent the decay of this important part of our built heritage. Grants will normally be for 25%-75% of eligible costs. The maximum grant is $\pm 5,000$ for non-freestanding war memorials while freestanding, non-beneficiary war memorials may be considered up to a maximum grant of $\pm 20,000$. The fund is open to anyone to apply; individuals or organisations, including councils.

URBAN TREE CHALLENGE FUND

Deadline:

Those wishing to plant trees in '23/24 must submit applications by 11:59pm on 30th June 2023. **Details:**

Grants are available to community/volunteer groups as well as town councils & individuals for tree planting projects in socially deprived urban & peri-urban areas. Funding aims to support people's health & wellbeing by levelling-up access to nature. The fund provides 80% of standard costs for planting large trees & their establishment costs. The remaining 20% must be met through match funding either in the form of money or labour. There is a minimum application value of £10,000. Payments for trial pits have been introduced in this round to check for the presence of services.

LOCAL AUTHORITY TREESCAPES FUND

Deadline:

Applications received after the 30th June 2023 will be considered for projects which plan to begin planting during the planting season in the 2024-2025 financial year.

Details:

Local Authority Treescapes fund aims to restore tree cover in non-woodland areas which may have been impacted by issues i.e., disease, habitat degradation or ageing tree stock. Funding is available to establish more trees in non-woodland areas i.e., parklands, riparian zones, urban areas, beside roads/footpaths, hedgerow trees & field boundaries. Grants of £50,000-£300,000 will be awarded to Borough, District/City Councils, County Councils, Unitary & Metropolitan Boroughs. Local authorities are encouraged to work with schools, other organisations, grass root organisations, community groups, & private individuals to deliver planting.

NATURE FOR CLIMATE PEATLAND GRANT SCHEME

Deadline:

Details on how to apply will be added to the Natural England website before applications open. **Details:**

Environmental groups, local authorities, charities, public bodies, individual landowners etc will be able to apply for funding to restore degraded peatlands. This competitive scheme aims to restore the whole hydrological unit of a peatland & reduce emissions from peat, with a goal of restoring 35,000 hectares of degraded peat by March '25. Applicants must have authority to carry out the activities in their proposal & demonstrate how their proposal will deliver the scheme's objectives, including wider benefits like improved ecosystems & biodiversity, better water quality, natural flood management, & protection of historic environment features. Restoration Grant applicants can normally apply for up to 75% of total project costs, & exceptional cases up to 85% of the cost. **How to apply:**

PRINCE'S COUNTRYSIDE FUND

Deadline:

The closing date for applications is the 11th April 2023.

Details:

Grants of up to £25,000 are available to support innovative projects that support the resilience & viability of communities in remote rural areas. The funding is keen to encourage applications from groups and organisations with projects in hamlets, villages and small market towns in remote rural locations where the project is required due to a lack of alternative services in that locality. Applications from small villages and towns, or rurally dispersed areas, will be prioritised over those from larger towns, which may be better served.

Not for profit, schools & statutory organisations can apply for grants of $\pm 300 \pm 800$ to organise events, activities & festivals that engage children & young people during the Great Big Green Week '23. The Great Big Green Week is a nationwide celebration of action on climate change, taking place from 10^{th} - 18^{th} June 2023. The fund is especially interested in hearing from groups that work with or support children and young people who come from low-income families, have migrated to the UK, are from racialised communities, have experience of the care system, are LGBT+ or from an LGBT+ family, or are disabled or live with someone who is disabled.

SPECIES RECOVERY PROGRAMME CAPITAL GRANT

Deadline:

The 2-year grant scheme will open for applications on the 3rd April 2023 for a period of 6 weeks. **Details:**

A new funding programme has been launched to help reverse the decline of threatened or endangered species. Species Recovery Programme Capital Grant Scheme will award grants of between £50,000 and £500,000 to partnerships, businesses, and organisations for activities such as habitat enhancement, equipment purchase, species translocation projects, the purchase and installation of new site infrastructure, staff costs, and some research and development. Match funding is encouraged, but not essential.

THE VETERAN'S FOUNDATION

Deadline:

The next closing date is the 24th April 2023 for consideration at the June Trustees meeting. **Details:**

Armed Forces charities and other not-for-profits can apply for grants of up to £40,000 for projects and activities supporting serving armed forces personnel, veterans, operationally qualified seafarers, and their immediate families. Types of grants awarded include:

- Grants of up to £30,000 for projects. This grant could be spread over up to three years.
- Grants of up to £40,000 are available exclusively for salaries over a two-year period.

The Foundation gives priority to charities & organisations who can demonstrate that they are directly involved in the provision of support to those in need, as well as well-run organisations of low to medium wealth. In awarding grants, a range of factors will be considered including the service or item being funded, number of beneficiaries, the importance of the grant to the applicant organisation, the efficiency of the organisation, need of the beneficiaries and its urgency. **How to apply:**

THE THOMAS WALL TRUST

Deadline:

Priority will be given to projects that target people experiencing multiple deprivation or other groups facing major hurdles to employment, especially, women, people with physical, mental, or learning disabilities, refugees, and asylum seekers. to be eligible the applicants must: be a UK charity that has been registered with the Charity Commission for at least 3 years, be a project or running costs for a charity that equips people (aged 18 and over) with the skills ready for employment & have an annual turnover of £10,000-£500,000.

NATURE FOR CLIMATE PEATLAND GRANT SCHEME

Deadline:

The closing date for applications is the 26th May 2023.

Details:

Environmental groups, local authorities, charities, public bodies, individual landowners, and organisations can apply for funding to restore degraded peatlands. The Nature for Climate Peatland Grant Scheme (NCPGS) Restoration Grants aims to restore the whole hydrological unit of a peatland and reduce emissions from peat, with a goal of restoring 35,000 hectares of degraded peat by March 2025. Restoration Grant applicants can normally apply for up to 75% of the total project costs, and exceptional cases can apply for up to 85% of the cost. Applications from partnerships or substantial land holdings are encouraged.

Scientific researchers and conservationists are invited to apply for funding for work that is aimed at the preservation of endangered species. Grants of up to £10,000 per annum for up to two years will be awarded to projects seeking to find the critical scientific evidence that will facilitate the conservation of one or more species or their habitat or provide the answer to a key conservation question that will enable conservationists to undertake critical conservation action.

Details:

Grants of £400-£1,600 are available to support local not for profits in providing a better start in life for children by addressing issues such as poverty, inclusion, and wellbeing. The U18 Better Starts Grant is part of the Asda Foundation's Grassroots Grants programme, which seeks to empower local groups to make a positive difference in their communities. The Childs Charitable Trust supports Christian UK registered/excepted charities & organisations both in the UK and overseas. Projects will be considered that fall into the following categories:

- Youth the trust looks to support projects working in schools and with vulnerable and disengaged young people in the UK. Supported activities may include RE Lessons; School Assemblies; Lunchtime/After school clubs; Evangelism; Personal Development Programmes; Homelessness Prevention.
- Outreach the trust works to share the gospel of Christ by supporting all aspects of Christian • outreach both in the UK and overseas and can fund, for example, Church Plants; Overseas Mission; Training in Evangelism; Chaplaincy.
- Society the trust believes people of faith bring a valuable contribution to social action and justice and support initiatives that have a positive impact in their society. Grants could support, for example: Counselling; night shelters; alcohol/drug rehabilitation; homelessness; or prison/ex-offender's work.
- Education the trust supports initiatives involved in all areas of Christian education including Bible Translation; Media Initiatives; Bible Colleges; Literature; Apologetics.

Applicants must be registered with the Charity commission or be 'excepted' charities. No minimum or maximum funding amounts are specified. The primary focus for grants allocated is on those organisations who actively share the Christian gospel in their work.

BBC CHILDREN IN NEED CORE COSTS FUND

Deadline:

Applications can be submitted at any time.

Details:

Grants of up to £120,000 are available for registered charities and not-for-profits working with disadvantaged children and young people aged 18 and under. The grants aim to support the core costs of these organisations, such as HR and payroll expenses, office costs, accountancy and audit, communications and outreach, and governance, regulatory, and compliance costs. Organisations can apply for grants of up to £40,000 per year for a maximum of three years, with most grants being lower. UK state schools can apply for grants of £2,000-£10,000 to set up or improve their libraries. Priority is given to primary schools up to Key Stage 2, but secondary schools that need books & reading resources for catch-up reading programs for Key Stage 3 pupils and/or transition reading programmes for feeder/local primary schools will also be considered. The foundation can also consider applications from special schools for all SEN age groups. Most of the funds will be awarded for physical library/reading books, but the foundation may also consider contributions towards e-readers & electronic reading resources with a strong case & explanation of need. Contributions towards library software, necessary IT equipment, & furniture are also possible. Applications must come directly from the school & cannot be submitted by PTAs.

Schools and not for profits can apply for funding. Wooden Spoon is the British & Irish Rugby charity which supports projects help mentally, physically disadvantaged children. Each year the charity supports around 70 projects. Funding is available for Buildings & extensions, Soft playrooms. Sensory rooms & gardens Playgrounds & sports areas; Equipment & activity aids. Funding available is for capital items only & will not support revenue costs such as staffing & other ongoing costs. There is no maximum grant limit but projects under £5,000 are unlikely to be considered. Wooden Spoon's contribution may be up to 100% of cost, though beneficiary organisations will be encouraged, where practicable, to raise a proportion themselves. If a project is educational or disability sports-focused, there must be rugby element to the engagement.
