As always it tends to come out in the month of June and probably will be released as the newsletter is distributed. As we know the document comes out as a draft first, with this in mind I have planned two briefings online to share with you any changes and the implications of the changes for education settings.

4. Safeguarding@ Emails

For advanced notice, following a recent safeguarding practice review, it has been identified that due to the wide range of email addresses being used across Halton, it can be difficult for agencies to get in touch with the right person in order to share vital information. Consequently, as agreed by the Education Sub-Group of the safeguarding partnership, we are going to move to a system of having a shared inbox for every school which uses the format safeguarding@. This email address can be shared with all DSLs within your school so that they all have access. Halton IT will look to create these inboxes for those who use Halton IT. If you use a different IT provider, please could we ask that this be set up and then the email address confirmed with Maria and Ben. Maria will explain more at the DSL workshops and Ben will also discuss this at the HT Meetings this term, but please be aware that this change is coming....

We hope to have this system established for a September launch.

5. Contact details – PLEASE ACTION TODAY

Many thanks to the 43 schools who have already updated their contact details as requested. Can I please ask schools to fill in the form (link below and it only takes 4 minutes to complete) with the relevant contact details for the members of staff in your school for each area identified? - <u>Please click on this link to update details</u>.

Once I have all these details I will be able to set up the shared point for all school documents as discussed in the Network Meetings and Education Subgroup. I am hoping to launch this by September.

Change of contact details

If your contact details change or somebody changes roles or is new to post within school please fill in the form so I can inform all the necessary departments of the settings/persons new contact details. This will help keep databases up to date. <u>Please click link to complete the form.</u>

6. Pilot group peer to peer support

During network meetings and the education subgroup meeting schools have asked about supervision. Therefore, I have launched a pilot scheme for group peer-to-peer support to all settings. This will take place monthly via teams until the end of the Summer Term.

Peer to peer support will provide an opportunity for DSL's/DDSL's/or a staff member you feel would benefit from this support to anonymously discuss cases/practice/emerging areas of concern. In return the group will provide a safe space to encourage open and honest professional conversations to enable professional thinking, challenge, reflection and analysis. Those involved will maintain neutrality in the process and facilitate group discussion on how to approach an on-going issue with the case. All those attending the group on the set date will be following confidentiality statements and adhere to group expectations. Attendance at settings has been limited, I am open to feedback on how we can look at the times/days or how the process works to encourage take up by settings.

7. LADO

8. Prejudicial / discriminatory incident reporting link

Thank you to those schools who have submitted incident forms. We have seen a decline in the submission of forms across Halton and this is in contrast to rises in reported incidents within other Local Authorities. I will be discussing the background and purpose of these forms in more detail in the DSL Workshop. The forms will be reviewed on half termly basis and feedback given to education settings on trends and patterns we have identified. This enables the Local Authority and education settings to respond in an effective way in implementing measures to address local contextual issues.

9. Safer Recruitment and HR requests

At this current time of year the Local Authority HR department and education setting are in their busiest period of recruitment. It is a priority for HR and settings to ensure that they have staff ready to commence employment at the start of the new academic year who have been through all the necessary pre-employment checks.

With this in mind, any education settings requesting historic information for personnel files may be experiencing some delays with HR returning the information. I strongly advise you make a note in the individual's personnel file of what you have requested from HR, the date requested and when sending the email request to HR ask the recipient to acknowledge your email through a read receipt.

If you are due Ofsted and receive a call HR have assured me that if you notify them and myself we will ensure documents are made available.

10. Virtual School

Inform the Virtual School!

Please remember to inform the virtual school about all significant changes or requests for LAC. This includes holiday requests, possible moves and changes in circumstances.

If a Looked-After Child is at risk of exclusion – get in touch – we can help!

If a child becomes 'Looked After', an initial PEP must be completed within 10 days – this is a statutory timescale which we need to stick to and will mean we need to act quickly!

11. SEND/Vulnerable Pupils Key Stage 2 to Key Stage 3 Transition Event

Monday 26th June 2023. This event is designed to allow all relevant parties involved in supporting transition to Key Stage 3 to be able to come together at once to discuss children with additional needs and at risk of exclusion as they enter their secondary education. At the event information can be shared which will aid a smoother entry into Year 7 and also allow pre-planning of any support which may be required for September.

Event Audience - All SENDCOs, Year 7 leads and Pastoral Teams from all Halton Settings. Also present will be representatives from specialist teaching and EP service.

14. SWGFL – Harmful Sexual Behaviour Support

Information regarding harmful sexual behaviour within schools continues to grow, as seen in the latest report by the Children's Commissioner, which considers the links between harmful sexual behaviour and pornography. To address this growth and support service cases, we have released free resources and guidance on how to identify and address harmful sexual behaviour in schools. Based on the knowledge and experiences of the Service practitioners, the resources include a series of templates, guides, and advice to support professionals working with children:

- Harmful Sexual Behaviour in Schools Resources, which include an FAQ and a series of templates to create school policies and risk assessments. These resources enable professionals to have a foundation to understand and assess harmful sexual behaviours, with further guidance on writing referrals to local children's services.
- Recognising Harmful Sexual Behaviour, to get advice and guidance on how to recognise and respond to harmful sexual behaviour in children and young people, and the different types of harmful sexual behaviours that can be identified.
- Online Safety Policy Templates for Schools, designed by Online Safety experts, these adaptable templates on e-safety help schools create an online safety policy to fit their needs.

Alongside these resources, service practitioners have created a video training package to support teachers, safeguarding leads and professionals working with children. The training module consists of nine videos that consider what harmful sexual behaviour is, and how schools and other organisations can appropriately respond to cases. In 2021, there were over 850 arrests across the UK for accessing child sexual abuse material every single month. Many of these individuals arrested are likely to have children of their own or within their wider family, meaning hundreds of families will find out a parent or carer has accessed child sexual abuse material each month. As such, it's incredibly important that social workers and wider professionals are able to make considered decisions to protect children in the home.

Created in collaboration with <u>The Lucy Faithfull Foundation</u>, our **Managing risk and trauma after online sexual offending: a whole-family safeguarding guide** is designed to help drive a confident professional response. To enable best practice in safeguarding and supporting the whole family, when a parent or carer has viewed and/or shared child sexual abuse material. <u>Click to access the guide.</u>

15. Online searches of shortlisted staff

Keeping Children Safe in Education 2022 included a mention of online searches as part of the appointment process. But what is actually expected of schools?

Not, as you will find out below, installing new social media apps and certainly not cyberstalking potential new colleagues. See below the original KCSIE quote followed by a very helpful clarification from DfE about what it does and does NOT mean.

"KCSIE 22 is not prescriptive in detailing the manner in which this check ['online search' in para. 221] is undertaken but care has been taken not to use the term 'social media' as this could be seen as invasive. Our guidance requests that schools and colleges consider an 'online search'. This should be a quick and simple search, which can be conducted via an internet browser.

We do not wish to place any unnecessary burdens on schools and colleges, nor encourage them to breach any individual's private life."

This aspect of recruitment will be discussed further in the upcoming safer recruitment training. It is advised that if you conduct an internet search on any short listed candidate you will have informed all those shortlisted this is part of your recruitment process.

16. School and College Security Guidance - UK Government

Regionally, there have recently been a number of incidents in the proximity to schools that have led to them being put into lockdown. These events provide a timely reminder to ensure that our schools has effective lockdown procedures to keep children safe inside the school. Whilst it is important to know what to do in these rare incidents, often this will mean ensuring staff know what to do, without unduly alarming pupils, especially younger children. 17. Omegle Guidance - Internet Matters

Omegle has been a headache for those concerned with protecting children for a decade and a half. On first glance the site is a simple internet chatroom, reminiscent of platforms from the internet's early years. It has no registration or account system. Being designed with the originally innocent objective of getting strangers to talk to each other, but this allows under-18s to easily use the platform, without needing parental assistance, money or even an email address. This already creates a dangerous situation to young pupils, but its insistence on users needing a webcam to chat places anyone underage in an extremely vulnerable place.
