Multi- Agency Plan (MAP) Training (DSL/DDSL/SENCO/Pastoral Staff)

In order to fulfil the statutory duties as set out in KCSIE 23 all education settings need to offer early help via a MAP when it has been identified early help is appropriate to support a child/ren. This training will provide the designated safeguarding lead (and/or a deputy DSL/SENCO) with the skills and knowledge needed to navigate/lead on liaising with other agencies and setting up an interagency assessment as appropriate. If you're feeling daunted with this task the locality team are

offering face to face MAP training, answering many common questions, support to use the system and a bank of resources to support the process.

Designated Safeguarding Governor Training

This training is specifically for those who have responsibility as the Designated Governor for Safeguarding within school settings. Safeguarding governors are the officials who ensure an effective understanding of safeguarding and how it's implemented within a school setting. The Competency Framework for Governance (DfE 2017), states that they should be 'confident in their challenge to executive leaders on strategies for monitoring and improving the behaviour and safety of pupils.' The training will support those in role to be familiar with specific areas of safeguarding which schools may have to manage, enable delegates to feel more confident and equipped in being a 'critical friend' to schools and provide resources and ideas to support their role.

8. Snap Chat – local ongoing safeguarding incident – ACTION REQUIRED

Please note we have an on-going Police investigation linked to a Snap Chat account called Runny S@@@. If you have any incidents in school linked to this account, please report to the Police via 101.

9. Crisis line for Children and Young People – mental health

See Children Hear Children Help Children The Mersey Care 24-hour response team is for young people up to the age of 18 experiencing emotional, behavioural or mental health difficulties which are causing difficulties in their school, family or social life.

Mersey Care NHS Foundation Trust

The service is for children and young people who are registered with a GP in Halton, Knowsley, St Helens and Warrington, up to their 18th birthday presenting in crisis needing an emergency response.

They provide:

- · No wrong front door for emergency referrals, providing advice and consultation to professionals, parents, carers and children and young people
- · Emergency assessment and follow up
- · Brief intervention and home treatment.

Within four hours they will do an assessment, a risk assessment, keep young people safe, offer advice to children and families, working with social care, schools and other professionals. You can contact the team on 01744 415 640 – 24 hours a day seven days a week.

10. Operation Encompass

I am pleased to update that following conversations with Cheshire Police they are looking at their new systems and how to try and support settings with further information on Operation Encompass notifications. They are looking at creating drop down boxes to support identifying the victim and perpetrators as well as relationships within notifications.

11. Virtual School

Please remember to inform the virtual school about all significant changes or requests for LAC. This includes holiday requests, possible moves and changes in circumstances.

If a Looked-After Child is at risk of exclusion – get in touch – we can help!

If a child becomes 'Looked After', an initial PEP must be completed within 20 days – this is a statutory timescale which we need to stick to and will mean we need to act quickly!

14. Missing from Home – support and case worker details

Trigger Meetings

As per the new Pan Cheshire MFH Protocol 2023 - 2024, the threshold for holding a stage 1 Missing From Home (MFH) intervention meeting has changed from 5 missing incidents in a 90-day period, to 3 missing incidents in a 30-day period. This level of trigger intervention meeting is the crucial stage in avoiding serious escalation and must, therefore, be given high priority by all concerned. It is for the YP's Social Worker/Lead Professional to ensure that all relevant agencies/individuals are. invited to MFH Intervention meetings. 16. Senior Mental Health Lead - DfE offers second grants.

The DfE has announced that eligible settings can apply for a senior mental health lead training grant to commence training by 31 March 2024. Relevant schools can also now claim a second grant to train a new person if the senior mental health lead they previously trained left their setting before embedding a whole school or college approach to mental health and wellbeing. The grant can be used to cover (or contribute to) the cost of attending a quality assured course and may also be used to hire supply staff while leads are engaged in learning.

The Department for Education offers grants of £1,200 for eligible state-funded schools and colleges in England to train a senior mental health lead to develop and implement a whole school or college approach to mental health and wellbeing. This training is not compulsory, but it is part of the government's commitment to offer this training to all eligible schools and colleges by 2025. Although independent schools are not eligible for a grant, all assured courses are available to their staff. 18. National Youth Advocacy Service (NYAS).

Since 2015, the Department for Education has commissioned a national advocacy helpline to support the rights of children to be heard. Since 2017, this helpline has been delivered through Coram Voice's 'Always Heard' service.

From 1st October, the national advocacy helpline service will be provided by the National Youth Advocacy Service (NYAS).

The Coram Voice 'Always Heard' Service will continue to operate and receive calls until 30^{th} September.

The NYAS 'Safety Net' helpline service will continue the national provision of:

- Helpline advice and support.
- Signposting to local services.
- Issue-based advocacy.
- Specialist non-instructed advocacy.
- Advocacy finder service.
- Self-advocacy information.

The service accepts referrals from children and young people, professionals working with young people, friends, families, and carers.

The service will be available to:

- Children in care and care leavers up to age 25.
- Children and young people needing support from children's services, including those on child in need plans, child protection plans, or who are 16-17 years old and homeless.

NYAS will also continue to support refugee and migrant children and young people, as well as young people in mental health settings.

17. CPOMS best practice - what next

18. New Information Sharing advice

Following recent serious case reviews in the UK where children have died or been seriously harmed through abuse or **neglect**, the Information Commissioner's Office (ICO) has released **new guidance** to improve **information sharing** practices and help safeguard children.

Data protection laws can make it challenging for those working with children to determine what personal information is safe to share. This guidance aims to build confidence about sharing information when you have concerns that a child or young person is at risk of harm.

The guidance is for any organisation that works with children and sets out 10 steps around:

- Being clear about data protection.
- Identifying objectives for sharing information.
- Following the data protection principles.

The ICO has also created <u>free marketing materials and a video</u> to help organisations raise awareness of the benefits of sharing information to protect children and young people from harm.
